## Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The Center for Drug Evaluation and Research (CDER) is responsible for regulating prescription drugs, including new drugs, generic drugs, biological products and biosimilars as well as over-

the-counter drugs (OTC). CDER's drug regulatory responsibilities include premarket review of new drugs and generic drugs; maintenance of the OTC drug monograph system; monitoring of all marketed drug safety and promotion activities; review, monitoring, and enforcement of drug quality during the entire drug life cycle; and ensuring drug products in the market comply with the law.

The Office of Pharmaceutical Quality (OPQ) oversees and coordinates the overall regulation of human pharmaceutical quality within CDER, including submission review, manufacturing facility assessment, and surveillance of the quality of marketed pharmaceutical products.

The Office of Biotechnology Products (OBP) serves as OPQ's centralized regulatory resource on biotechnology drug assessment and research. OBP regulates biological products and biosimilar biological products and supports OPQ in the overall regulation of human pharmaceutical quality.

## Duties/Responsibilities

As **Division Director**, the incumbent partners with the Office Director and Deputy Office Director in providing scientific leadership and management of review, regulation, and research assuring the safety, efficacy, and quality of biological products and biosimilar biological products as specified by the Public Health Service (PHS) Act and applicable provisions of the Federal Food, Drug & Cosmetic (FD&C) Act through their product lifecycle.

- Collaborates with the Office Director to formulate and develop short-term and long-range goals, policies, and standards for assessment of investigational new drugs (INDs), biological product license applications, post-market manufacturing supplements and pre-license/pre-approval inspections.
- Provides leadership and guidance to the division on matters related to the execution of appropriate actions on INDs related to therapeutic biological products and subsequent amendments.
- Provides leadership and technical authority involving the development and implementation of manufacturing standards for the efficacy and quality assessment of drugs.
- Manages collaborative research and contract support activities in the areas of immunology, biochemistry, and chemistry required for the regulation of therapeutic biological products.

**Supervisory Responsibilities:** Manages the functional discipline, providing leadership and management oversight to subordinate staff. Supervises and evaluates staff of branch chiefs who serve as experts in their field. Provides occupational specific technical and administrative

direction and supervision 25 percent or more of the time to subordinate staff performing the work and functions of the organizational unit. Obtains and identifies strategic objectives for the organization.

## Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.

- One-year supervisory probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

  - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

Degree: biological sciences, agriculture, natural resource management, chemistry, or related disciplines appropriate to the position. Or a combination of education and experience with courses equivalent to a major listed plus appropriate experience or additional education.

**Microbiology, AD-0403 Series:**

Degree: microbiology; or biology, chemistry, or basic medical science that included at least 20 semester hours in microbiology and other subjects related to the study of microorganisms, and 20 semester hours in the physical and mathematical sciences combining course work in organic chemistry or biochemistry, physics, and college algebra, or their equivalent. ## Education Transcripts

## Security Clearance Requirements

Background Investigation/Security Clearance Requirements: Non-Sensitive/High Risk

If not previously completed, a background security investigation will be required for all appointees.
