Introduction

The Food and Drug Administration (FDA or Agency) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The Center for Biologics Evaluation and Research (CBER) is a Center within FDA that regulates biological products for human use under applicable federal laws, including the Public Health Service Act and the Federal Food, Drug, and Cosmetic Act. CBER's mission is to protect and enhance the public health through the regulation of biological and related products including blood, vaccines, allergenics, tissues, and cellular and gene therapies. CBER protects and advances the public health by ensuring that biological products are safe, effective, and available to those who need them. CBER also provides the public with information to promote the safe and appropriate use of biological

products.

Duties/Responsibilities

Position Summary:

The Deputy Division Director reports to the Director for the Division of Program Services (DPS). The incumbent provides leadership and management of a diverse, interdisciplinary staff of 17 FDA employees in the Immediate Office of the Director and two branches, the Program Services Branch (PSB) and the Safety and Services Branch (SSB).

Duties/Responsibilities:

The Deputy Division Director assists the Director in managing the daily operations of the Division. As Deputy Director, the incumbent is responsible for assisting the Director in directing CBER's responsibilities related to physical security and safety management services.

The Deputy Director regularly serves as a close advisor to the DPS Director. The incumbent is responsible for fully implementing the requirements of specific Equal Employment Opportunity, Food and Drug Administration (FDA), and Department of Health and Human Services (HHS) programs. The incumbent additionally carries out and supports other special HR programs of the Federal Government, HHS, and FDA as needed.

Specifically, the Deputy Division Director will:

- Serve as CBER's Deputy Ethics Counselor Point-of-Contact (DECPOC) by coordinating and supervising the CBER's Ethics Program.
- Provide oversight to the Chief of the Safety and Services Branch (SSB) which oversees the general safety of all CBER personnel and ensures compliance with OSHA, CDC, and USDA regulations and Chief of the Program Services Branch (PSB), which provides facility and space liaison services to employees, supervisors, and managers.
- Serve as the primary liaison to Shared Services for property and facilities management.
- Provide oversight to CBER Physical and IT Security Liaisons, responsible for coordination with Agency Security groups ensuring safety of CBER employees and the data the Center managers.
- Provide oversight to CBER Accountable Property Program, managing a portfolio of over 5,000 pieces of equipment with a value of over \$70 million dollars.
- Be responsible for ensuring all applicable contracts are in place for lab equipment purchase and maintenance necessary for fulfilling CBER's mission.

Supervisory Responsibilities:

Organizational Management: Assists in managing a Division.

Program Management: Runs a functional activity. Oversees multiple projects. Identifies inputs and outputs needed to perform functional activities.

Resource Management: Consolidates and balances resource needs of multiple projects in a functional activity or Division.

Personnel Performance Management: Counsels and rates immediate subordinates.

Human Capital Management: Identifies ways to meet employee competency goals.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.

Qualifications

 - a. **Qualified** applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the [OPM Qualification Standards](#) as a baseline for comparing experience levels and other candidate attributes for relevant positions.
 - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

- Leadership coaching, training, or certification;
- Prior management and/or operations experience with the FDA;
- Expertise in facilities, safety and ethics processes and programs;
- Ability to build and work effectively within teams;
- Ability to work collaboratively with diverse staff and stakeholders; and
- Ability to prioritize and make critical decisions.
- Experience with multiple aspects of federal facilities, safety and ethics processes included but not limited to:
 - Physical and IT Security
 - Facilities related matters including accountable property management
 - Federal ethics regulations
 - Safety related programs
- Ability to coordinate and integrate complex facility related projects.
- Experience in supervising facilities, safety and ethics teams in setting goals and expectations in a clear manner to all members.
- Motivating groups to accept opinions or take actions related to: advancing fundamental goals and objects of facilities, safety and ethics programs and/or advancing fundamental goals and objects of related programs.
- Knowledge of HHS Federal Acquisition and Budget related systems
- Experience with facility planning processes environments for purposes of Five Year Strategic Facility Plan
- Experience supervising or coordinating acquisitions programs pertaining to statements of work, performance work statements, statements of objectives, independent government cost estimates, paying invoices, contract close-outs, grants, purchase cards, and/or broad agency announcements.

- Experience and familiarity with the federal ethics regulations as related to 450s, 520s and Conflicts of Interest
- Experience in FDA systems as relates to facilities, accountable property, program budget management and ethics.
- Experience in working in HHS wide systems in all applicable areas.
- Communicating with staff at all levels of a federal organization including but not limited to Agency Executives, Directors, Deputy Directors.

Education Transcripts
