#### Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices are safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over the counter and prescription drugs, including biological therapeutics and generic drugs.

The Office of New Drugs's (OND) public health mission is to protect and enhance the health of the public through the review and evaluation of scientific data submitted by pharmaceutical manufacturers in support of both investigational new drug application and new drug applications, and to determine if candidate drugs are safe and effective.

## Duties/Responsibilities

As a **Project Coordinator**, the incumbent directly supports the development and review of regulation of medical products.

- Assist the regulatory manager or an assigned group of drug/biologic products or office level programs with activities that include coordination of applications from the investigational stage through marketing application review, and post-marketing safety oversight.
- Work with an interdisciplinary team to facilitate the day-to-day management of all application reviews or office level programs.
- Coordinates and tracks all industry meeting request to ensure that specified timelines are met.
- Reviews all assigned applications to confirm that all information required by law or federal regulation is present in the submission.
- Identifies risks that may adversely impact the quality or timeliness of review activities; advises management and other team members of the potential impact on the project and recommends solutions to mitigate the risks.

This position can be performed throughout the OND Offices, Divisions, Branches, and Staffs located in the Office of Regulatory Operations.

## **Conditions of Employment**

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.

- Ethics Clearance may be required.

 Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

  - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

# **Education Transcripts**

<u>SUBMITTING YOUR TRANSCRIPTS:</u> Positions which are scientific or technical in nature often have very specific educational requirements.
