### Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential

public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over the counter (OTC) and prescription drugs, including biological therapeutics and generic drugs.

The Office of Strategic Programs (OSP) is responsible for quantitative and qualitative data analysis, program evaluation, business process modernization, decision support services to facilitate effective operations, consultation to Center Offices in developing strategic and operational plans for CDER, cross-center management and coordination of work on Center-wide governance and special initiatives, and the implementation of IT solutions to meet CDER's business needs. OSP provides essential expert support and enabling services for CDER to meet its mission objectives.

The Business Informatics Governance Staff (BIGS) oversees the development and management of the CDER enterprise-wide IT strategy; develops strategic roadmaps aligned with the IT strategy to modernize and innovate CDER's drug regulatory operations.

This position is in the CDER Immediate Office supporting the Business Informatics Governance Board's (BIG) Informatics Program Management Office (IPMO).

# Duties/Responsibilities

As an **Informatics Program Manager**, the incumbent will support the planning and execution of major technology programs consisting of multiple projects:

- Proactively identifies and implements qualitative and quantitative methods, techniques, and tools such as risk registers and issue tracking that are relevant to ensure continued progress on implementation of technology solutions supporting CDERs internal operations.
- Engages with iPMO staff and key CDER internal stakeholders such as technology liaisons that enable prioritization and support the planning and delivery of technology initiatives and solutions, by maintaining a knowledge of business needs and initiatives within CDER.
- Provides oversight to technology projects by independently create a project scope and vision, that adequately reflects project and CDER customer's needs and expectations and educates others on how to apply it throughout project communications.
- Facilitates the track a project's risk register, issues, and project progress by gathering and evaluating project burn down charts; Identify, collect, and consolidate program risks from multiple projects

## **Conditions of Employment**

- Ability to constructively interact with a wide variety of stakeholders within and outside the Center, including senior leadership and external contractors.
- Experience communicating verbally with a wide variety of audiences, including the ability to communicate technology concepts to senior management effectively, ability to modulate communication approach depending on audience, and ability to derive and communicate underlying insights, risks, and root causes from diverse program data sources.
- Experience applying an understanding of one or several complex technology programs.
- Bachelor's degree in information systems or a related technical field such as computer science, engineering, MBA, or advanced technical degree is preferred.
