Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices are safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over the counter and prescription drugs, including biological therapeutics and generic drugs.

The Office of New Drugs' (OND) public health mission is to protect and enhance the health of the public through the review and evaluation of scientific data submitted by pharmaceutical manufacturers in support of both investigational new drug application and new drug applications, and to determine if candidate drugs are safe and effective.

This position can be performed throughout the OND Offices, Divisions, Branches, and Staffs located in the Office of Regulatory Operations.

Duties/Responsibilities

As a **Consumer Safety Officer**, the incumbent will serve as the regulatory manager/coordinator for an assigned group of office level programs. Activities may include coordination oversight of programs.

- Work with an inter-disciplinary team to facilitate the day-to-day management of office level program activities.
- Work with project management, clinical and non-clinical review staff to facilitate the day-to-day management of all application reviews or office level programs.
- Tracks the overall progress of programs and initiatives by creating project plans, timelines, and other supporting materials to expedite the communication and completion of program review activities by all relevant disciplines.

Supervisory Responsibilities: N/A

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.
- Males born after December 31, 1959 must be registered with the Selective Service.
- One-year probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

Qualifications

To be placed into a Cures position, candidates must meet the following criteria:

- 1. Scientific, Technical, and Professional Fields
- 2. Qualified and Outstanding Candidates
 - a. Qualified applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the <u>OPM Qualification Standards</u> as a baseline for comparing experience levels and other candidate attributes for relevant positions.
 - b. *Outstanding* candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

To qualify for this Title 21 Cures position, the candidate(s) must meet the following <u>required</u> qualifications. Please note: Additional education and experience listed that is not indicated as <u>required</u> is preferable and desired. Candidates who do not meet the "desired" criteria will <u>not</u> be excluded from consideration for this position.

Education Transcripts

<u>SUBMITTING YOUR TRANSCRIPTS:</u> Positions which are scientific or technical in nature often have very specific educational requirements. Even if you hold a similar position or are a current FDA employee, you are not exempt from transcript requirements.

Security Clearance Requirements

Background Investigation/Security Clearance Requirements: Non-Sensitive, Moderate Risk

If not previously completed, a background security investigation will be required for all appointees. background security investigation or supplemental investigation may be required later.
