Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the

health of people in the United States. CDER regulates over the counter and prescription drugs, including biological therapeutics and generic drugs.

The Office of Strategic Programs (OSP) is responsible for quantitative and qualitative data analysis, program evaluation, business process modernization, decision support services to facilitate effective operations, consultation to Center Offices in developing strategic and operational plans for CDER, cross-center management and coordination of work on Center-wide governance and special initiatives, and the implementation of IT solutions to meet CDER's business needs. OSP provides essential expert support and enabling services for CDER to meet its mission objectives

The Office of Program and Strategic Analysis (OPSA) is responsible for quantitative and qualitative data analysis, business process analysis and improvement, and program evaluation to support senior management decisions. OPSA provides consultation services to Center Offices in developing and implementing proposals for key strategic initiatives and priorities, evaluating the impact of operations and policies on external stakeholders, and in conducting evaluation studies to inform Center strategy and policy position on emerging issues in drug regulation.

The Economics Staff (ES) mission is to serve as the CDER focal point for economic analysis, provide economic insight into complex economic phenomena and how they affect the public health, and assisting and advising CDER leadership on the economic considerations in policy formulation and implementation of policies and programs. In effort to support this goal, the economics staff is increasingly utilizing data science to speed up and expand data collection and to study questions using novel analytical methods developed in data science.

Duties/Responsibilities

As a **Data Scientist**, the incumbent serves as a mastery data scientist providing consultative services as needed to Center leadership and other program leaders.

- Independently, creates and facilitates the concretization, design, and conduct of complex quantitative studies leveraging internal and external data to inform decision making in CDER regarding operations and policy.
- Evaluates and independently chooses the most appropriate analytical methods, concepts, and tools for a single project and/or entire area of investigation. This includes selecting the appropriate analytical techniques and data needed to study difficult quantitative questions. Techniques include all aspects of data science, with particular focus on forecasting using machine learning techniques, including boosting models, random forest models, survival models, classification models, regression models, mixed effect models, and other relevant techniques as applicable to the specific challenges at hand.
- Applies novel or uncommon data science methods to solve novel analytical challenges. Applies appropriate design and application of analytical process to gather and analyze

applicable quantitative and data to diagnose challenges. Evaluates findings, examines areas of strengths and areas which require improvement. As the SME, validates the analyses and models conducted by more junior staff.

- Determines the best application of programming and visualization tools, including the following: R, R Studio, R Shiny, Python, SQL, SAS, Julia, Tableau, or related tools as needed. Incumbent trains and works with junior staff members in the application of best practices of the tools.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.

- Skill in applying the principles, concepts, tools, and methodologies related to data science. Experience utilizing advanced forecasting and predictive analytical techniques, including machine learning techniques.
- Experience utilizing R, Python, SQL, SAS, Julia, or Tableau.
- Demonstrated skill and experience developing complex and high-quality analytical work products in support of program operations, policies, and/or resource allocation decision-making.
- Demonstrated ability to work independently and collaboratively across organizational boundaries.
- Experience effectively and efficiently communicating with various audiences, both verbally and in writing.
