Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices are safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over the counter and prescription drugs,

including biological therapeutics and generic drugs.

The Office of New Drugs's (OND) public health mission is to protect and enhance the health of the public through the review and evaluation of scientific data submitted by pharmaceutical manufacturers in support of both New Drug (NDA) and Investigational New Drug applications (INDAs), and to determine if candidate drugs are safe and effective.

Duties/Responsibilities

As a **Social Science Analyst**, the incumbent serves as an expert and is responsible for the evaluation of a variety of complex study endpoint issues to support labeling claims including the evaluation and measurement of treatment in clinical trials. The incumbent will also be responsible for:

- Serving as one of OND's leading experts on the development and validation of clinical outcome assessments, which include patient reported outcome, clinician-reported outcome, and observer-reported outcome measures as well as performance outcome measures.
- Reviews and provides corresponding advice to stakeholders (including FDA decision-makers, medical product sponsors and instrument developers) on studies used in clinical outcome assessment development and validation.
- Participates in developing guidances for industry and other policy development that address social science and measurement issues pertaining to study endpoints and patient-focused drug development.
- Advises the Team Leader on various regulatory policy matters related to the use of patient-reported outcomes in new drug development and the new drug review process.
- Collaborates with other scientific personnel who are reviewing clinical study results to be certain that treatment benefit decisions are consistent with federal regulations.

Supervisory Responsibilities: None

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.
- Males born after December 31, 1959, must be registered with the Selective Service.

- One-year probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation/Security Clearance is required. All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.

Desired Education, Qualifications, and Experience:

Our ideal candidate will possess:

- A relevant master’s or doctoral degrees (health services or health outcomes research, educational research, psychology/sociology, public health, pharmacy, medicine, osteopathy).
- One year of instrument development or survey methodology experience (qualitative and/or quantitative methods).
- Ability to adapt to a changing environment and manage multiple priorities.
- Excellent writing, oral communication, and analytical skills.

Education Transcripts

SUBMITTING YOUR TRANSCRIPTS: Positions which are scientific or technical in nature often have specific educational requirements. A transcript is required to verify educational

Background Investigation/Security Clearance Requirements: Non-Sensitive/Moderate-Risk

If not previously completed, a background security investigation will be required for all appointees.
