Introduction

The Food and Drug Administration (FDA) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The mission of the Center for Drug Evaluation and Research (CDER) is to perform an essential public health task by making sure that safe and effective drugs are available to improve the health of people in the United States. CDER regulates over-the-counter and prescription drugs,

including biological therapeutics and generic drugs.

The mission of the Office of Compliance (OC) is to shield patients from poor quality, unsafe and ineffective drugs through proactive compliance strategies and risk-based enforcement actions. CDER OC strives to be a model of efficiency, innovation, and operational excellence. Guided by law and science, the Office makes strategic and risk-based decisions, communicates clearly with all stakeholders, fosters global collaboration, promotes voluntary compliance, and takes decisive action.

The mission of Office of Scientific Investigation (OSI) is to develop and implement patient focused, risk-based programs and policies for inspection, compliance, and enforcement of the following regulatory areas: nonclinical and clinical drug product studies, bioequivalence studies, human subject protections in clinical drug product studies.

The Division of Enforcement and Postmarketing Safety (DEPS) in Office of Scientific Investigations (OSI), develops and implements compliance and enforcement programs, including the review of significantly violative inspections that may result in compliance or enforcement action that were conducted under the direction of Office of Translational Science (OTS) or OSI inspection programs.

Duties/Responsibilities

As a **Consumer Safety Officer** in the Division of Enforcement and post marketing Safety (DEPS) in OSI, the incumbent will have responsibilities related to the ClinicalTrials.gov compliance and enforcement program. Serves as a Consumer Safety Officer on an assigned team in the Compliance Enforcement Branch (CEB) within DEPS.

- Evaluates responsible parties of applicable clinical trials for compliance with Clinicaltrials.gov registration, certification, and results reporting requirements, and takes appropriate administrative and enforcement action as necessary.
- Identifies and describes challenging problems and issues in areas where nominal policy guidance exists. Works with team leader and supervisor in resolving problems, modifying procedures, and developing and implementing guidance, some of which form the basis for formal regulatory decision-making and policy direction.
- Conducts briefings, presentations, and meetings with other CDER and FDA Offices conducts research in support of the development of external briefings and official statements.
- Represents OSI on CDER committees and participates in professional meetings with regulated industry and with foreign regulatory counterparts as an OSI representative. Participates in internal and external working groups, scientific symposia, and public workshops.
- Maintains skills through continuing education and professional development, by literature research and writing, and by staying abreast of the state-of-the art technologies and emerging scientific advances.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.

Degree: A bachelor's or graduate/higher level degree in quality assurance or a related degree that included at least 30 semester hours in one or a combination of the following: consumer laws, biological sciences, food science, chemistry, pharmacy, physical sciences, food technology, nutrition, medical science, engineering, epidemiology, veterinary medical science, legal investigations, law enforcement, or related scientific fields that provided knowledge directly related to consumer safety officer work. The 30 semester hours may include up to 8 semester hours in statistics, or course work that includes the principles, theory, or practical application of computers or computer programming.

OR

Combination of education and experience courses consisting of at least 30 semester hours in the fields of study described in paragraph A above, plus appropriate experience or additional education. The education must have been obtained at a college, university, or an accrediting body recognized by the Secretary, U.S. Department of Education at the time the degree was obtained.

Background Investigation/Security Clearance: Non-Sensitive/High Risk

If not previously completed, a background security investigation will be required for all appointees. Appointment will be subject to the applicant's successful completion of a background security investigation and favorable adjudication.
