We have approved your request received October 31, 2022, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for Prothrombin Complex Concentrate (Human) [Kcentra®] to revise the wording in the Prescribing Information for Section 5.2 (Warnings and Precautions, Section 5) and Section 6.2 (Adverse Reactions, Section 6) based on the data from the phase 4 observational study BE1116_4001.

LABELING

The SPL will be accessible via publicly available labeling repositories.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125421 at the time of use and include implementation information on Form FDA 356h.

ADVERTISING AND PROMOTIONAL LABELING

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes this change.

We will include information contained in the above-referenced supplement in your BLA file.
