The U.S. Food and Drug Administration (FDA) intends to procure a rotating beam fatigue tester meeting or exceeding the salient characteristics as outlined in the Statement of Work below. This announcement serves as the solicitation for this requirement (Solicitation # CDRH-2023-118237) and is being issued as a Request for Quotation (RFQ). The RFQ is issued in accordance with FAR Part 13 procedures and additional supplemental information included in this notice. The incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2023-02.

This announcement constitutes the only solicitation and a separate solicitation will not be issued. The NAICS Code for this solicitation is 334519 (Other Measuring and Controlling Device Manufacturing) with a small business size standard of 600 employees. This requirement is being solicited as an open-market total small business set-aside; only quotations submitted from small businesses will be considered for award. Prospective quoters are responsible for downloading the solicitation and any amendments from the FDA eBidBoard.

The deadline for receipt of quotations for this requirement is: Tuesday, May 23, 2023 at 10:00 a.m. Eastern Time (ET). - 1.1 The Contractor shall submit a fixed price quote, including details of all costs supporting the price for the requested items/services.

- 1.3 Quotes shall be in two volumes: Volume I shall be Technical and Volume II shall be Price. The volumes shall be separate and complete, so the evaluation of one may be accomplished independently of, and concurrently with, the evaluation of the other. No pricing information shall be provided in Volume I. This volume shall provide the equipment description including specs, warranty, delivery, etc. and not exceed 10 pages in length.
- 1.4 Quotes shall clearly reference the solicitation, date of quotation, company quoting and point of contact.
- 1.5 The Contractor's current address and Unique Entity ID shall be included in the quote.
- 1.6 Quotes shall be for all the items requested.
- 1.7 Quotes shall be valid for at least 60 days after close of solicitation.

## 2. AWARD CRITERIA:

Quotations that do not respond to all requirements in the solicitation may be rejected without further evaluation, deliberation, or discussion. The Government reserves the right to award without discussions. The Government contemplates award of a Firm-Fixed-Price Purchase Order resulting from this solicitation to the responsible quoter whose quote conforming to the solicitation will be most advantageous to the Government and whose quote is the Lowest Priced Technically Acceptable (LPTA).

### \*\*\*\*\*STATEMENT OF WORK\*\*\*\*\*

#### A. BACKGROUND

The FDA is responsible for protecting the public health by assuring the safety, efficacy, and security of human and veterinary drugs, biological products, medical devices, our nation's food supply, cosmetics, and products that emit radiation. The FDA is also responsible for advancing the public health by helping to speed innovations that make medicines and foods more effective, safer, and more affordable, and helping the public get the accurate, science-based information they need to use medicines and foods to improve their health.

The mission of the Center for Devices and Radiological Health (CDRH) is to protect and promote the public health. CDRH assures that patients and providers have timely and continued access to safe, effective, and high-quality medical devices and safe radiation-emitting products. CDRH provides consumers, patients, their caregivers, and providers with understandable and accessible science-based information about the products CDRH oversees. CDRH facilitates medical device innovation by advancing regulatory science, providing industry with predictable, consistent, transparent, and efficient regulatory pathways, and assuring consumer confidence in devices marketed in the U.S.

The Office of Science and Engineering Laboratories (OSEL) supports the CDRH's mission of protecting and promoting public health. The OSEL undertakes the highest quality science to provide their customers with the best methods, tools, and expertise to:

- i. Ensure readiness for emerging and innovative medical technologies
- ii. Develop appropriate evaluation strategies and testing standards
- iii. Create accessible and understandable public health information and
- iv. Deliver timely and accurate decisions for products across their life cycle

The Division of Applied Mechanics, Office of Science Engineering Laboratories, which is a part of the FDA Center for Devices and Radiological Health, (FDA/CDRH/OSEL/DAM) is in need of a Rotating Beam Fatigue Tester.

#### B. SCOPE OF WORK

The overall objective of this requirement is to procure a Rotating Beam Fatigue Tester that conducts 4-point beam loading conditions. This will enable FDA/CDRH/OSEL/DAM to complete an in-progress project, Critical Path (Assessment and Perspective of Additive Manufacturing Variability on Medical Device Performance). This will support the FDA/CDRH/OSEL/DAM with specialized equipment for this project and future projects as FDA/CDRH/OSEL/DAM studies variability between traditional materials and additively manufactured materials.

Future research will also use this fatigue tester. FDA/CDRH/OSEL/DAM's existing machines are approximately 30 years old and have reached end of life. A new Rotating Beam Fatigue Tester is needed to validate the variability of wrought and additive manufactured titanium as part of the project.

##### **1. System Requirements and Deliverables:**

FDA/CDRH/OSEL/DAM requires that the Vendor shall indicate if the minimum salient characteristics for the Rotating Beam Fatigue Tester have been met to be considered responsive for this requirement:

- i. The Rotating Beam Fatigue Tester shall have a capability of testing at a Bending Moment of at least 200 lb-in.
- ii. The Rotating Beam Fatigue Tester shall have a variable frequency brushless motor delivering at least 1 HP.
- iii. The Rotating Beam Fatigue Tester shall be capable of a rotational Speed of at least 3,600 RPM.
- iv. The Rotating Beam Fatigue Tester shall consist of 0.5-inch straight shank ER32 collets and be capable of testing 0.5-inch diameter samples. The Rotating Beam Fatigue Tester should also have the ability to add other collets for other sample dimensions.

- v. The Rotating Beam Fatigue Tester shall have a cycle counter capable of counting to 99,999,999 revolutions.
- vi. The Rotating Beam Fatigue Tester shall consist of a linear actuator coupled with a load cell.
- vii. The Rotating Beam Fatigue Tester shall have capabilities of providing a 4-point beam loading condition.
- viii. The laboratory at the agency is set to a cool temperature to accommodate backup power systems and various heat generating systems. Therefore, the Rotating Beam Fatigue Tester shall have an operating temperature range of +10 to +40°C or wider.
- ix. The Rotating Beam Fatigue Tester shall be able to operate in a wide range of humid atmospheres. Therefore, the Rotating Beam Fatigue Tester shall have a humidity operating range of 10 to 90%, non-condensing or better.
- x. The Rotating Beam Fatigue Tester shall not require internet connectivity to operate as described in these salient requirements.

## **2. Other General Requirements:**

- i. The Rotating Beam Fatigue Tester shall already be designed, built, validated, and sold on the U.S. market.
- ii. The Rotating Beam Fatigue Tester shall not be a custom design.
- iii. All components in the Rotating Beam Fatigue Tester shall be new. The components shall not be used nor refurbished.
- iv. The Rotating Beam Fatigue Tester shall be Underwriters' Laboratories (UL) compliant. The system shall be built and certified at the Rotating Beam Fatigue Tester's manufacturing facility.
- v. The Rotating Beam Fatigue Tester shall have complete manuals and instructions in digital format so the user can operate the Rotating Beam Fatigue Tester within the salient requirements stated in the award. These manuals and instructions shall be available on the vendor's website as long as they are accessible and downloadable by the agency.
- vi. All manuals and instructions for the Rotating Beam Fatigue Tester shall be in clear English.

## **3. Warranty, Maintenance and Technical Support**

Shall include a minimum of one (1) year comprehensive warranty from the date of receipt and acceptance including telephone and email support communication for one year on the purchased equipment. Technical support shall be furnished at no additional cost during the warranty period. The vendor shall cover all equipment repair costs within the warranty time period that are the result of general in-specification use of the Rotating Beam Fatigue Tester.

## **D. INSPECTION AND ACCEPTANCE**

The Project Officer or their designee that initiated the tasking or designated manager has the authority to accept or reject services. The acceptance of service and satisfactory work performance required herein shall be based upon the timeliness, accuracy and suitability of the service. The specific services and schedule for service shall be as agreed upon and documented.

Inspection and acceptance will occur at the place of delivery (destination). Inspection will include testing of the deliverables to ensure that they work. The Government will accept goods, reports, and services only if they conform to all terms and conditions of this order. The Government will provide written notification of acceptance or rejection within ten (10) business days of receiving the delivery.

The Government will reject any non-conforming products and services.

*Inverted domestic corporation*, means a foreign incorporated entity that meets the definition of an inverted domestic corporation under [6 U.S.C. 395](#)(b), applied in accordance with the rules and definitions of [6 U.S.C. 395](#)(c).

*Manufactured end product* means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

## **II.12 52.225-18 PLACE OF MANUFACTURE (AUG 2018)**

(a) *Definitions.* As used in this provision --

"Manufactured end product" means any end product in Federal Supply Classes (FSC) 1000-9999, except-

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

(b) For statistical purposes only, the offeror shall indicate whether the place of manufacture of the end products it expects to provide in response to this solicitation is predominantly--

(1)  In the United States (Check this box if the total anticipated price of offered end products manufactured in the United States exceeds the total anticipated price of offered end products manufactured outside the United States); or

(2)  Outside the United States.
