Introduction

The Food and Drug Administration (FDA or Agency) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The Center for Biologics Evaluation and Research (CBER) is a Center within FDA that regulates biological products for human use under applicable federal laws, including the Public Health Service Act and the Federal Food, Drug, and Cosmetic Act. CBER's mission is to protect and enhance the public health through the regulation of biological and related products including blood, vaccines, allergenics, tissues, and cellular and gene therapies. CBER protects and advances the public health by ensuring that biological products are safe, effective, and available to those who need them. CBER also provides the public with information to promote the safe and appropriate use of biological products.

Duties/Responsibilities

The Associate Director serves as the Principal Policy Advisor to the Center Director and leads the Center's activities on planning, developing, and implementing programs and policies for biological products and other products regulated by CBER. Directs policies involving the regulation of CBER-regulated products, including those involving clinical trials, pre-and post-market approval issues, real world evidence, patient engagement, counterterrorism, labeling, manufacturing, communications, human subject protection, emerging infectious diseases, and novel and emerging technologies. Oversees Center's policy activities on legislative matters and communications.

The Associate Director is the senior policy liaison with FDA centers, the Office of the Chief Counsel and the Commissioner's Office and with other agencies on CBER policy matters. Responsible for the review and clearance of regulatory policy

programs and strategic initiatives. In addition, directs the Center's Regulations and Policy Staff.

Supervisory responsibilities:

Organizational Management: The Associate Director leads the Center's activities on planning, developing, and implementing programs and policies for biological products and manages a Staff.

Program Management: Runs a multi-disciplinary program in the Center. May run two or more smaller, multi-disciplinary programs in the Center. Identifies specific activities needed to achieve desired outcomes. Organizational staffing patterns are primarily homogeneous, but may also have staff in various scientific, professional, technical, or administrative occupational series.

Resource Management: Monitors and reports on resources needed to run an Office or a multi-disciplinary program in the Center.

Personnel Performance Management: Counsels and rates immediate subordinates.

Human Capital Management: Identifies employee competencies necessary to meet organizational capabilities goals.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Males born after December 31, 1959, must be registered with the Selective Service.
- One-year supervisory probationary period may be required.

Qualifications

2. Qualified and Outstanding Candidates
 - a. **Qualified** applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the [OPM Qualification Standards](#) as a baseline for comparing experience levels and other candidate attributes for relevant positions.
 - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.
