Availability Update for Select Oncology Products

Dear Valued Customer,

Pfizer Hospital is committed to providing timely supply information so that you can plan for patient care. Due to increased demand arising from competitive shortages, we want to make you aware that multiple presentations of **Carboplatin Injection, Docetaxel Injection, USP and Methotrexate Injection, USP** vials are experiencing a temporary limited supply and intermittent stockout situation as noted in the Product Table below.

Pfizer has been working diligently and increasing output above our historical volumes amidst these competitive shortages, but market demand continues to exceed Pfizer's production capacity. At this time, our estimated supply recovery timeline remains dependent on resolution of competitive shortages.

To help ensure equitable distribution of inventory and mitigate long-term stockouts of Pfizer products, we will release limited quantities to wholesalers and via direct shipment, where applicable depending on NDC, on a weekly basis as product becomes available.
