**Statement of Work**

The Food and Drug Administration (FDA), Center for Biologics Evaluation and Research (CBER), Laboratory of Biochemistry and Vascular Biology (LBVB) requires an upgrade package to their Zeiss Observer Z1 microscope with a new monochrome camera and new software to improve the image quality and resolution of the images obtained with the laboratory's current microscope, plus installation of the new camera on the Observer Z1 microscope. The laboratory has found a camera that meets their needs: the Zeiss Axiocam 820 Mono, or equal and Zen software.

A significant focus of the lab's research centers on the effects of blood products and microbial pathogens on the vascular endothelium in various organ systems (e.g., heart, kidney, brain, lung, and liver) and cell culture systems. Making detailed observations by brightfield and fluorescence microscopy of animal tissue specimens and cells is vital to ascertain the safety and efficacy of these biological treatments. To improve image quality and resolution, the lab needs to upgrade the software and monochrome camera of the Zeiss microscope. This upgrade will allow the lab to take much improved pictures for publication and make more accurate observations about the effects of blood products and microbial pathogens.

In broader terms, this camera and stage upgrade will be used to evaluate the effect of biologics on various animal tissues and cell culture systems. The upgrade will be used to characterize the safety of biologics and evaluate the pathogenic mechanisms of bioterrorism threats. This upgrade will support multiple projects within the Biochemistry and Vascular Biology Laboratory.

**Salient characteristics that an "or equal" product must meet:** The monochrome camera shall:

1. Be compatible with the current Zeiss microscope (model: Observer Z1, serial #: 3851002267).
2. Be at least 20 megapixels
3. Be capable of at least 28 full-resolution images per second
4. Have active thermal stabilization
5. Be USB 3.0 compatible
6. Include the newest version of Zen software (Zen 3.7).
7. Be warranted for no less than 1 year.
