Requirement

The Food and Drug Administration (FDA), National Center for Toxicological Research (NCTR)'s Division of Biochemical Toxicology requires tissues (i.e. reconstructed human pigmented epidermis models) to execute dermal absorption experiments aimed at elucidating the impact of skin pigmentation from known race on permeation of FDA-regulated cosmetic ingredients and contaminants. The reconstructed human pigmented epidermal models will comprise human keratinocytes cultured together with human melanocytes (melanin/pigment producing cells of the skin) and will be grown at the air-liquid interface to facilitate skin barrier development.

Minimum Specifications for the Reconstructed Human Pigmented Epidermis Models:

1. The tissues must have known donor race.
2. The tissues shall consist of human keratinocytes co-cultured with human melanocytes and matured to present as a stratified epidermis-like structure.
3. The tissues shall come in three (3) independent shipments, each consisting of 48 total tissues (each shall be supplied as a 9 mm in diameter specimen).
4. Each shipment shall consist of 24 tissues comprising human melanocytes from Caucasian/White donors and 24 tissues comprising human melanocytes from African American/Black donors.
5. Each shipment shall contain enough culture media to pigment 24 tissues for 14 days and control media to maintain 24 tissues for 14 days.
