Dear Mr. Hoffner:

We have approved your request received January 20, 2023, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for Diphtheria and Tetanus Toxoids and Acellular Pertussis Adsorbed and Inactivated Poliovirus Vaccine (KINRIX), manufactured at your Rixensart (b) (4) facilities in Belgium, to update the package insert to remove information regarding the single-dose vial presentation due to its discontinuation.

LABELING

CONTENT OF LABELING

Content of labeling must be identical to the Package Insert submitted on January 20, 2023. The SPL will be accessible via publicly available labeling repositories.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125260, at the time of use and include implementation information on Form FDA 356h.

ADVERTISING AND PROMOTIONAL LABELING

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes these changes.

We will include information contained in the above-referenced supplement in your BLA file.
