**Requirement**

The Food and Drug Administration (FDA), Center for Evaluations and Research (CBER), Office of Therapeutic Products (OTP), plans and conducts research related to the development, manufacture, and testing of cellular, gene therapy (including those utilizing naturally occurring viral vectors and those prepared by genetic engineering and synthetic procedures), therapeutic vaccines, and plasma-derived and coagulation products in order to develop and maintain a scientific base for establishing standards for safety, purity, potency, and effectiveness. In addition, it develops policy and procedures to ensure the continued safety of human cells, tissues, and cellular and tissue-based products (HCT/Ps) for risk of communicable diseases. For such research purposes, the laboratory staff of the Office of Plasma Protein and Therapeutics (OPPT), which is within OTP, seeks to procure Andexxa:

200 mg vials, four (4) vials per set, quantity: 1 Set. This drug is prescribed to treat patients with rivaroxaban or apixaban, when reversal of anticoagulation is needed due to life-threatening or uncontrolled bleeding.

This RFQ is for a **Brand Name solution only**. Substitutions for an “or equal” product are precluded. Product needs to meet all the specifications listed below to be deemed technically acceptable.

**Minimum Specifications/Requirements:**

1. The Contractor shall provide 200 mg vials, 4 vials per set, quantity: 1 Set of Andexxa which shall be packaged securely and shipped to the customer’s address.
2. Due to the restrictions for the purchase of these prescription drugs, the offeror must have a DEA license and be able to legally purchase and supply these drugs for the FDA’s use for research purposes.
3. Due to restrictions for the purchase of prescription drugs, the shipping address cannot be changed.
4. Shipment shall take place at the beginning of the week to prevent shipment over a weekend.
5. Contractor shall notify Contracting Officer and Technical Point of Contact (TPOC) when shipment takes place to ensure TPOC can be on the lookout for them.
