Inventory Management Update for Pfizer Hospital Rocky Mount Products

Dear Customer,

On August 3, 2023, we shared that out of an abundance of caution we were taking additional steps to manage inventory on a small subset of Rocky Mount presentations of high medical need via our emergency order process. **Based on further assessment, today we are adding two additional presentations listed in the table below to our emergency ordering process via direct shipment from Pfizer only.** Please note that there is remaining inventory in the wholesaler/distribution chain, and customers should check availability through their wholesaler and exhaust all channels to obtain product or appropriate therapeutic alternatives prior to making an emergency request.

We believe this emergency order process is the most responsible approach to enable equitable distribution of remaining inventory of products with high medical need while we work to restart production. Customers may reference all presentations subject to the emergency ordering process in the Appendix of this letter.

Emergency Order Instructions

- Customers should place emergency orders through their Pfizer Hospital representative or account executive. If you do not know your Pfizer Hospital representative, emergency orders may also be placed via the Pfizer Hospital Supply Continuity Team, available between 7 am and 5 pm CST at 1-844-646-4398 (select option 1 [Customer], then option 3 [Supply Continuity Team]).
- Orders will be reviewed in the order they are received and will be released in limited quantities based on available inventory. Cut off time for overnight requests is 12 pm (CST), and no shipments will occur on Sundays. Customers may not receive their full requested amount in each case, but we will strive to ensure every customer receives some product.
- Your representative will keep you apprised of the fulfillment status of your order.
- Given the importance of these products, we kindly request that customers exhaust all channels to obtain product or appropriate therapeutic alternatives prior to making an emergency request.

Our sterile injectable medicines are of great importance to patients, and we are committed to recovering our supply as soon as possible. We appreciate your patience and partnership during this time.
