

This is a combined synopsis/solicitation for commercial items prepared in accordance with the Federal Acquisition Regulation (FAR) format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested. This requirement is being issued in conjunction with FAR Part 13 Simplified Acquisition Procedures. This solicitation is issued as a Request for Quote (RFQ).

The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2023 June 2, 2023.

The associated North American Industry Classification System (NAICS) Code is-333912- **Air and Gas Compressor Manufacturing**; Small Business Size Standard is 1,000 employees. This RFQ is issued as full and open competition.

The Tobacco Products Laboratory (TPL) is seeking the purchase of a new oil-free air compressor and relocation of existing compressor. The proposed equipment will enable TPL to meet the legislative requirements (associated with The Family Smoking Prevention and Tobacco Control Act) and the accompanying sample load that will accompany The Food and Drug Administration (FDA) response to the legislation. The FDA needs this instrumentation to develop intelligence in this previously unregulated area through working with fellow regulatory Agencies and developing our own analytical expertise in tobacco analyses.

This compressor is designed to supply high-quality oil-free compressed air necessary for the operation of multiple tobacco physical testing instruments, in furtherance of analyses associated with the Family Smoking Prevention and Tobacco Act. The physical testing instruments are used to characterize tobacco products and their associated components.

The government is seeking disconnection and relocation of current shop compressor. And purchase an oil-free rotary (scroll) air compressor for physical testing room/instrumentation, to include installation.

The vendor shall provide these minimum performance requirements:

GENERAL

1. The Contractor shall supply all labor and equipment to lock out/tag out energy supply to existing pneumatic air compressor.
2. The Contractor shall disconnect the existing piping and electrical wiring from the current compressor.
3. The Contractor shall remove and relocate the existing compressor to a storage location.
4. Installation of high-quality oil-free rotary (scroll) air compressor.
5. The system shall be delivered with all necessary supplies and accessories required for installation and start-up.
6. The Contractor shall supply all labor and equipment to install the new compressor in the same location of the existing air compressor.
7. The Contractor shall connect the new air compressor to existing pneumatic piping.
8. The Contractor shall supply labor, material, and equipment to terminate new air compressor power wiring into the existing junction box.

9. The components and/or equipment shall be a newly manufactured, not used and refurbished, or previously used for demonstration.
10. The entire system shall be warranted for parts and labor for a minimum of 12 months from date of formal government acceptance. The warranty must include unlimited telephone/e-mail support for questions regarding operation. On-site response time for repairs during the warranty period should be no more than 72 hours, if needed. As needed, factory-certified replacement parts, engineer labor and travel costs, software updates, notifications, and installation shall be included to ensure maximum system operational readiness.
11. OEM Factory Authorized Service shall be provided at 2000 hours of compressor operation and 4000 hours of compressor operation from date of installation.
12. Shall be delivered with all necessary supplies and accessories required for immediate use.
13. Delivery must include the “inside delivery (to the specified location)” and setup at vendor’s expense. Vendor is responsible for removal of all packing and shipping materials to include crates and pallets at vendor’s expense at the completion of install/setup.
14. The vendor shall provide all travel, labor and parts at no additional charge. There shall be at least one (1) scheduled maintenance visit per year of the contract.

RECORDS AND REPORTS

The Contractor shall, commensurate with the completion of each service call (inclusive of warranty service), provide the end-user of the equipment with a copy of a field service report/ticket identifying the equipment name, manufacturer, model number, and serial number of the equipment being serviced/repared and detailing the reason for the service call, a detailed description of the work performed, the name(s) and contact information of the technician who performed the repair/service.

SALIENT CHARACTERISTICS

The contractor shall provide all resources necessary to accomplish the tasks and deliverables described in this Statement of Work (SOW). The Contractor shall provide the compressor and accessories that meet or exceed the requirements described below. All of the following are minimum requirements. Equivalent requirements that differ from these minimum requirements must be justified by the proposing vendor and evaluated by the Tobacco Products Laboratory (formerly Southeast Tobacco Laboratory) prior to purchase.

****Offerors shall address each of the salient characteristics in order to be considered.****

- The system shall be equipped with a ¾-inch motorized ball valve in the pneumatic air supply piping between the air compressor tank and pneumatic air dryer to block the air supply if power to the auto tank drain and or air dryer was interrupted. This valve would consist of one (1) 120-volt single phase actuator, normally closed, power to open, spring return, ¾-inch FNPT, 2-way, 2-position.
- Contractor shall provide a new high-quality oil free rotary (scroll) air compressor.

- The new compressor shall work with, and connect to, existing air dryer, Quincy model QPNC-30.

 - The Quincy Model QPNC-30 pneumatic air dryer, 30 CFM @ 100 PSIG, 115V/1ph, 39-degree dewpoint, diagnostic display, high-efficiency heat exchanger, 10-year heat exchanger warranty, dielectric zero loss drain and one (1) Wilkerson pneumatic condensate separator: 1/2 in NPT, 50 CFM, 200 PSI max op pressure, auto drain.”
- The system shall be delivered with all necessary supplies and accessories required for installation and start-up.
- The Contractor shall supply all labor and equipment to install the new compressor in the same location of the existing air compressor.
- The Contractor shall connect the new air compressor to existing pneumatic piping.
- The Contractor shall supply labor, material, and equipment to terminate new air compressor power wiring into the existing junction box.

(B) The IRS has filed a notice of Federal tax lien with respect to an assessed tax liability, and the taxpayer has been issued a notice under I.R.C. §6320 entitling the taxpayer to request a hearing with the IRS Office of Appeals contesting the lien filing, and to further appeal to the Tax Court if the IRS determines to sustain the lien filing. In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability.
