The associated North American Industry Classification System (NAICS) Code is 334516 – Analytical Laboratory Instrument Manufacturing; Small Business Size standards – 1,000 employees. This requirement is being competed Unrestricted Basis. It is not a small business set-aside.

Background

Multiple ORA labs routinely use the Cary 60 UV-Vis Spectrophotometer for regulatory analyses of foods and medical products, including chemical methods such as color additive analysis and microbiological methods such as the measurement of alkaline phosphatase activity. The instrument records full spectrum absorbance measurements for a solution based on light beams that pass through a sample compared to reference beams that do not. This technology is robust and stable, has been in use for over 80 years, and is still commonly used in routine analyses. The instruments to be upgraded remain fully functional but are 12 years old and the current workstation and software are outdated and only Windows XP-compatible. To continue using these instruments, they require upgrading the CaryWinUV to the latest software version, which also requires upgrading the associated computer workstations to Win 10 or higher. This software is proprietary from the manufacturer (Agilent Technologies) and while new Windows 10 computers can be obtained from other sources, the manufacturer won't install/warranty the system if we load their software onto a third-party computer.

Objectives

Upgrade the two DENLHAF Cary 60 UV-Vis spectrophotometers identified below to the latest version of the CaryWinUV software to continue using these instruments on the secure FDA laboratory network for regulatory work. This software requires computers running Windows 10, which also requires updating the associated workstations, which are over 10 years old and run Windows XP.

Tasks

System Requirements

The proprietary instrument software (CaryWinUV) used to collect and analyze data from two Cary 60 UV-Visible Spectrophotometers must be upgraded to the latest CaryWinUV version that is compatible with Windows 10.

The associated workstations that interface with the instrument must be replaced with computers capable of running the software and have the Windows 10 operating system installed.

Installation and subsequent functional verification for regulatory use must be performed on the upgraded system by a qualified Field Service Engineer (FSE).

Records and Reports

The Contractor shall, commensurate with the completion of installation, functional verification, and regulatory compliance checks (if any), provide the end-user of the equipment with a copy of the service report identifying the equipment name, manufacturer, model number, and serial number of the equipment being certified, and a detailed description of the work performed. This will include the name(s) and contact information of the engineer who performed the service.

HHS Section 508 and Accessibility Standards

- (1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or
- (2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
