Introduction

The Food and Drug Administration ([FDA or Agency](#)) is the regulatory, scientific, public health and consumer protection agency responsible for ensuring all human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices safe, and effective.

The mission of the Center for Devices and Radiological Health ([CDRH](#)) is to protect and promote the public health by performing essential public health tasks by making sure that medical devices and radiological health products are safe for people in the United States. The [Office of Strategic Partnerships and Technology Innovation | FDA](#) (OST) provides leadership for all scientific collaborative and emerging technology related activities at CDRH. We represent CDRH with a broad and diverse array of national and international entities including other

government agencies, Congress, industry, academia, consumer and patient organizations, and healthcare professional organizations, with mutual interests in medical devices and radiation-emitting products.

Duties/Responsibilities

This position is in the Division of Technology and Data Services (TDS), Office of Strategic Partnerships and Technology Innovation (OST), Center for Devices and Radiological Health (CDRH). The Information Technologist will serve as a user interface/user experience (UI/UX) Information Technologist is responsible for creating high-quality, seamless user experiences for users. The incumbent optimizes the functional experience and creates polished and distinctive branded experiences for products and applications. Applies user-centered design principles and techniques and works with other development team members to inform and improve solution design.

The UI/UX Information Technologist will collaborate with business and technology stakeholders to develop a shared understanding of business and user goals and influence design making across multidisciplinary teams. The UI/UX Information Technologist is responsible for developing wireframes to share with users, and iterate upon design, based on feedback. The incumbent will be responsible for establishing a short and long-term UI/UX vision and strategy for products and applications.

The UI/UX Information Technologist is expected to develop a deep understanding of the customer journeys, personas and segmentation and translate that knowledge into documented artifacts and wireframes. The incumbent is expected to collect and analyze user behaviors and needs through qualitative and quantitative user research such as interviews, studies, surveys, digital experience monitoring and usability testing. The incumbent will also design and develop solutions to address critical user pain points and opportunities to increase efficiencies and apply user-centered design processes that incorporate data, user insights and feedback.

The incumbent will develop and communicate design ideas through various mechanisms, including, but not limited to, prototypes, wireframes, and user flows. The UI/UX Information Technologist is responsible for ensuring all applications and products meet objectives for usability, adhere to relevant design and accessibility standards, comply with the FDA strategy, and identify guidelines and deliver positive experiences.

The incumbent is responsible for translating user research insights into actual deliverables; serves as a technical authority on best practices, UI/UX tools, research methods and techniques, including usability testing, contextual inquiry, etc.; and communicates strategy and designs to various stakeholders and builds consensus to articulate the impact of design decisions on the end user, and business outcomes which may be affected.

The UI/UX Information Technologist is responsible for providing expert advice on design disciplines, including, but not limited to, interaction design, user interface design, information

design and graphic design. They will have the ability to distill complex concepts into design concepts and requirements.

Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.

Qualifications

To be placed into a Cures position, candidates must meet the following criteria:

1. Scientific, Technical, and Professional Fields
2. Qualified and Outstanding Candidates
 - a. **Qualified** applies to all candidates for Cures appointments. The FDA OTS will use the basic requirements defined in the [OPM Qualification Standards](#) as a baseline for comparing experience levels and other candidate attributes for relevant positions.
 - b. **Outstanding** candidates can be defined by existing outstanding work experience, outstanding performance rating, or both.

In order to qualify for this Title 21 Cures position, the candidate(s) must meet the following **required** qualifications. *Please note: Additional education and experience listed that is not indicated as **required** is preferable and desired. Candidates who do not meet the “desired” criteria will not be excluded from consideration for this position.*

Education Requirement: A bachelor's degree or higher in a computer science, cybersecurity, information science, information systems management, technology, engineering field. The degree must be from an accredited program or institution.

OR

Experience: Experience requirements include at least one of the following:

- Experience that demonstrates knowledge of the software design, development, and testing lifecycle.
- Experience that demonstrates knowledge of enterprise architecture, business architecture, systems architecture, service-oriented architecture, or data architecture, or frameworks of the same.
- Experience that demonstrates knowledge of IT management, IT helpdesk support, system integration, IT project management, IT Finance, or IT Acquisitions.
- Experience that demonstrates knowledge of managing IT transformation programs, managing IT innovation programs, or implementing disruptive technologies.
- Experience that demonstrates basic knowledge of technology and data processing functions, data extraction, transformation, loading, automation, and other aspects of data management.
- Demonstrated ability to meet the standards of a skills assessment test to be administered by the agency during the candidate process (i.e., pre-employment).
- Experience that demonstrates knowledge of the user experience design, development, and testing lifecycle.

Experience may have been gained in work such as CIO/CTO/other IT executive, IT manager, IT services manager, enterprise transition manager/planner, enterprise architect, business analyst, systems integrator, systems administrator, programmer, program analyst, or other positions that required the management of, use, or adaptation of computer programs and systems. Experience in creating and presenting/communicating complex technical information to a variety of stakeholders and leadership, both verbally and in writing. Experience in authoring policy and guidance.

Desired Skills: Continually abreast of latest developments with the UI/UX community and possesses expertise in leading edge technology and tools. Work requires a good understanding of agile and lean development practices and governance. Possesses strong presentation skills.
