We have approved your request received on August 10, 2023, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for delandistrogene moxeparovovec-rokl to extend the in-use hold time of the drug product, ELEVIDYS, in filled syringes from 4 hours to 6 hours.

LABELING

CONTENT OF LABELING

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes these changes.

We will include information contained in the above-referenced supplement in your BLA file.
