## Area of Consideration: Open to all Career/Career Conditional FDA Employees

On June 22, 2009, the President signed the Family Smoking Prevention and Tobacco Control Act (Tobacco Control Act) (Public Law 111-31) into law. The Tobacco Control Act granted FDA important new authority to regulate the manufacture, marketing, and distribution of tobacco products to protect the public health generally and to reduce tobacco use by minors. To carry out this responsibility, FDA established the Center for Tobacco Products (CTP).

## **Major Duties:**

The selected employee will serve as a Regulatory Counsel in the Office of Compliance and Enforcement (OCE) Division of Promotion, Advertising and Labeling (DPAL), Regulatory Submission Review Branch. Duties may include:

- Resolving a broad range of issues concerning the application of any of FDA's enabling legislation, pertinent regulations, and/or general legislation affecting the operation of the Federal government.
- Reviews and evaluates evidence for legal and administrative action recommendations, coordinates activities, and prepares documentation in support of enforcement of the Family Smoking Prevention and Tobacco Control Act.
- Identifies the key technical issues, evaluates alternatives for complex administrative and technical standards, regulations, or policies, and makes recommendations to senior management related to application and interpretation of existing laws and policies, and/or significant developments in the industry.
- In developing written statements concerning agency process or policy, the incumbent consults with staff at all levels of the Agency, to identify areas of disagreement within the Center or between the Center and other units of FDA, to resolve disagreements through the use of decision memoranda or through meetings, and to articulate any process or policy consensus.

Qualifying specialized experience includes:

- Knowledge of legislation, regulations, and guidance affecting FDA's Center for Tobacco Products.
- Solid foundation in regulatory review work.
- Excellent oral and written communication skills.
