Attached is the FONSI for FCN 2338 which explains how the Food and Drug Administration (FDA) has met the requirements under the National Environmental Policy Act (NEPA) for this FCN. FCN 2338 is for the use of amines, bis(hydrogenated palm-oil alkyl)hydroxy (CAS Reg. No. 1374859-51-4), as an antioxidant and/or stabilizer in olefin polymers, intended for single and repeat food-contact use, except for use in contact with infant formula and human milk .

FINDING OF NO SIGNIFICANT IMPACT

Food Contact Substance (FCS) Notification (FCN) 2338: submitted by Chitec Technology Co., Ltd., for the safe use of amines, bis(hydrogenated palm-oil alkyl)hydroxy (CAS Reg. No. 1374859-51-4), as an antioxidant and/or stabilizer in olefin polymers, intended for single and repeat food-contact use, except for use in contact with infant formula and human milk.

The Office of Food Additive Safety has determined that allowing this notification to become effective will not significantly affect the quality of the human environment and, therefore, an environmental impact statement (EIS) will not be prepared. This finding is based on information submitted by the notifier in an environmental assessment (EA) dated February 2, 2024. The EA was prepared in accordance with 21 CFR 25.40. The EA is incorporated by reference in this Finding of No Significant Impact and is briefly summarized below.

The FCS will be used at levels not to exceed 0.1 percent of the finished olefin polymer. Polypropylene (with a density of 0.85-0.91 gram per cubic centimeter) and high density polyethylene (with a density not less than 0.94 gram per cubic centimeter) homopolymers and copolymers containing the FCS may be used in contact with food types I, II, IV-B, VI-A, VI-B, VII-B and VIII under Conditions of Use A through H as described in Tables 1 and 2, and food types III, IV-A, V, VI-C, VII-A, and IX under Conditions of Use B through H as described in Tables 1 and 2. Other polyethylene (with a density less than 0.94 gram per cubic centimeter) homopolymers and copolymers containing the FCS may be used in contact with food under Conditions of Use B through H as described in Table 2. The FCS is not for use in contact with infant formula and human milk.

Items manufactured with the FCS are expected to be land disposed or combusted proportionately with disposal patterns described in U.S. Environmental Protection Agency's (EPA) report "Advancing Sustainable Materials Management: 2018 Tables and Figures." Discarded items will go to landfills or municipal solid waste (MSW) combustion facilities complying with 40 CFR Parts 258 and 60, respectively. Since these items will not be recycled, they will not interfere with recycling patterns. The FCS will not significantly alter the emissions from properly operating MSW combustion facilities, and incineration of the FCS will not cause these facilities to threaten a violation of applicable emissions laws and regulations at 40 CFR Part 60 and/or relevant state and local laws.

Total annual emissions of greenhouse gases (GHG) resulting from disposal of items containing the FCS, are expected to be below the 25,000 mT GHG reporting threshold described in 40 CFR 98.2. Therefore, no significant impacts are expected from incineration of the FCS at MSW combustion facilities.

Use of the FCS is not expected to result in a net increase in the use of energy and resources, because it is expected to replace, to a certain extent, other substances already in use. Manufacture of the FCS and its fabrication in food-contact articles will consume energy and resources in amounts comparable to the manufacture and use of materials already in use.

No significant environmental impacts are expected from use and disposal of the FCS; therefore, mitigation measures have not been identified. The alternative of not allowing the FCN to become effective would be the continued use of the materials that the subject FCS would otherwise replace; such action would have no significant environmental impact.

Consequently, we find that use of the FCS as an antioxidant and/or stabilizer in olefin polymers, intended for single and repeat food-contact use will not cause significant adverse impacts on the human environment. Therefore, an EIS will not be prepared.
