BACKGROUND:

This request is to obtain a contract with a biotechnology service provider to perform a monoclonal antibody (MoAb) development service project which will include immunizing mice, creating hybridoma fusions, screening the fusion products for relevant MoAbs, expansion and subcloning of selected clones, and in-vitro IgG production and purification from those clones.

Our laboratory is currently in need of a MoAb development service project to isolate antibodies specific to the six-helix bundle conformation of the SARS-CoV-2 spike protein. These MoAbs are needed to develop understanding of the conformational changes undergone by the spike protein during the fusion process and how this might affect neutralization of SARS-CoV-2.

SCOPE

We wish to obtain a service contract with a vendor that has the expertise and abilities to perform a MoAb development project for the development of MoAbs that are specific for the six-helix bundle conformation of the SARS-CoV-2 spike protein.

Part II: Work Requirements

A. Technical Requirements

The service provided will include the following steps:

REQUIREMENTS:

- Immunizations and Serum screening: 5 mice will be immunized three times with the appropriate antigen. Sera from mice will be screened by the vendor using ELISA to the antigens and an irrelevant HIS tagged protein and sera from the mice, or ammonium sulfate precipitated antibody from the sera of the mice, will be sent to the FDA for ELISA screening by the FDA to choose the mouse with the highest titer to proceed to fusion.
- Fusions and fusion screening: Splenocytes from the chosen mouse will be fused with a myeloma cell line to generate hybridoma cells expressing monoclonal antibodies and seeded to twenty 96-well plates for growth and screening. Parental cultures from the fusion will be screened by the vendor using an ELISA to the immunizing antigen and an irrelevant HIS tagged protein. Positive supernatants from up to 20 parental cultures, will be returned to the FDA for further screening by the FDA to select the desired cultures.
- Subcloning: Up to 20 cultures, as chosen by the FDA will undergo one round of subcloning with ELISA screening as above. Supernatants from these subclones will be provided to the FDA for screening. Up to 5 subclones, as chosen by the FDA, will undergo additional subcloning with ELISA screening as above till the final hybridoma clone is isolated. Supernatants from these subclones will be provided to the FDA for screening.
- IgG production: IgG will be produced in-vitro (cell culture) from each clone for up to 5 clones selected by the FDA, and 10-15 mg of purified IgG will be produced for each clone.

DELIVERABLES:

Because it is not possible to guarantee the successful isolation of a monoclonal hybridoma with the desired reactivity as outlined below, all work will be done on a “best effort” basis.

1. Two vials of frozen cells and 5 ml of culture supernatant for each of the final subclones with positive reactivity to the provided immunizing antigen (up to 5 clones as selected by the FDA) will be delivered to the FDA.
2. 10-15 mg of purified IgG produced in cell culture from each of the final subclones with positive reactivity to the provided immunizing antigen (up to 5 clones as selected by the FDA) will be delivered to the FDA.
3. Serum or serum antibody and culture supernatants will be provided to the FDA for screening during the project as outlined in the technical requirements above.

PLACE OF PERFORMANCE:

Work will be performed at the location of the contractor producing the monoclonal antibodies.
