### Introduction

The Food and Drug Administration (FDA or Agency) is the regulatory, scientific, public health and consumer protection agency responsible for regulating human and animal drugs, medical devices, cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, tobacco and radiation emitting devices.

The Center for Biologics Evaluation and Research (CBER) is a Center within FDA that regulates biological products for human use under applicable federal laws, including the Public Health Service Act and the Federal Food, Drug, and Cosmetic Act. CBER's mission is to protect and enhance the public health through the regulation of biological and related products including blood, vaccines, allergenics, tissues, and cellular and gene therapies. CBER protects and advances the public health by ensuring that biological products are safe, pure, and potent. CBER also provides the public with information to promote the safe and appropriate use of biological products.

## Duties/Responsibilities

The incumbent serves as a Consumer Safety Officer in the Blood and Tissue Compliance Branch (BTCB) within the Division of Case Management (DCM) under the Office of Compliance and Biologics Quality (OCBQ) within CBER. The Consumer Safety Officer will bridge the gap between the advisory role of headquarters and operational experience acquired as a Biologist, Microbiologist, Chemist, other scientific discipline or Investigator.

Specifically, the Consumer Safety Officer will:

- Perform at an expert level of technical competence in the area of blood and blood products, HCT/P (Human Cells, Tissues, and Cellular and Tissue Based Products), and medical device manufacturing practices as they apply to manufacturers of BECS (blood establishment computer systems) and procedures to bear in analyzing significant facts and developing logical conclusions regarding the regulation of biological products.
- Review and analyze Biological Product Deviation Reports (BPDRs) submitted by manufacturers of blood and blood products and HCT/Ps regulated by CBER, and apply Title 21, Code of Federal Regulations (21 CFR) Part 7, as appropriate.
- Be responsible for a full range of compliance actions, both administrative and judicial, including casework and related advisory opinion functional responsibilities in biological drugs and devices.
- Transmit the agency's decision regarding recommended judicial actions to the Office of Chief Counsel for initiation of court proceedings or authorizes the appropriate field office to issue a citation for hearing.
- Notify the district when regulatory action is not indicated with reasons thereof.
- Provide the Office of Chief Counsel with the necessary facts from the available files and obtain such additional information as may be deemed necessary to support the proposed court action.
- Collaborate with attorneys in the Office of Chief Counsel assigned to handle regulatory actions, providing specialized subject matter guidance, locating, or serving as an expert witness and assisting in the organization and preparation of evidence for the most effective presentation during the trial.
- Develop the agency position in response to requests for advisory opinions for the regulated industry, Congress, department officials, etc.
- Discuss, at conferences and during interviews, the problems at hand with scientific and medical personnel within FDA, as appropriate, to establish the scientific/medical basis for action or to identify and recommend an FDA position or stand when policy is nonexistent or inapplicable.
- Plan and implement educational programs for the FDA staff regarding developmental support of administrative and legal actions, in coordination with other FDA and CBER components.
- Draw conclusions based on finding and recommends a specific reply to the inquiry, specifying new policy interpretations and need to new or revised policy.
- Review inspection reports submitted by field investigators to determine compliance with applicable laws and regulations, and the need for follow-up investigation by the field.
- Perform other duties as assigned.

## Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
