**Summary:**

The Food and Drug Administration is the regulatory, scientific, public health, and consumer protection agency responsible for ensuring that all human and animal drugs, and medical devices are safe and effective; that cosmetics, foods, food additives, drugs and medicated feeds for food producing animals, and radiation emitting devices are safe; and that all such products marketed in the U.S. are adequately, truthfully and informatively labeled and safely and properly stored, transported, manufactured packaged and regulated.

The mission of the Center for Biologics Evaluation and Research (CBER) is to protect and enhance the public health through the regulation of biological and related products including blood, vaccines, allergenics, tissues, and cellular and gene therapies.

**This position is being filled under a stream-lined hiring authority, Title 21, Section 3072 of the 21st Century Cures Act. The candidate selected for this position will serve under a career or career-conditional appointment and be paid under the provisions of this authority.**

#### **Duties:**

The incumbent serves as a Consumer Safety Officer in the Field Programs Branch (FPB) within the Division of Inspections and Surveillance (DIS) under the Office of Compliance and Biologics Quality (OCBQ) within CBER. The Consumer Safety Officer applies their knowledge in compliance and enforcement to review and analyze a variety of cases ranging in complexity. The Consumer Safety Officer investigates health fraud; performs internet investigations of fraudulent products; and evaluates and makes recommendation on compliance actions related to fraudulent products. The incumbent is responsible for supporting the Office of Inspections and Investigations (OII) through the development of compliance programs and various compliance related documents in addition to facilitating communication between OII, CBER, and other government entities (i.e. State partners).

Specifically, the Consumer Safety Officer will:

- Perform undercover investigations to support CBER initiatives through internet investigations.
- Coordinates CBER operational activities related to the investigation of health fraud.
- Perform compliance and enforcement actions; advisory, administrative, and judicial, including casework and related functional responsibilities in the area of CBER regulated products.
- Recommends compliance actions related to fraudulent products.
- Analyze and determine the adequacy of proposed compliance and enforcement actions by an FDA Center/Office regarding the compliance and enforcement of regulated products with the Federal Food, Drug, and Cosmetic Act.
- Manages and coordinates the updates to the CBER compliance programs and assists advising other FDA components on these programs.
- Coordinates meetings and manages the process in preparation of comprehensive surveillance and compliance programs.
- Reviews establishment inspection reports for licensed and/or unlicensed establishments for correct interpretation of regulations, significance of deviations reports, and adequate documentation to support regulatory action.
- Participates in work groups in the preparation of guidance documents concerning inspectional procedures and compliance policies.
- Participates in the development of the Agency position in response to requests or advisory opinions from the regulated industry, covering the full range of subject matter within the assigned work area.
- Participates in discussions with scientific and medical personnel within FDA to assist with the establishment of precedent for action or to identify and recommend an FDA position when policy is non-existent or not applicable.
- Serves as a contact point for inquiries from both CBER and investigators for guidance concerning appropriate actions against non-complying licensed and/or unlicensed biological product establishments in accordance with compliance programs and Agency/Center policy.
- Participates in meetings with CBER staff and management for the purpose of discussing and offering solutions to industry issues, trends, violations, and policy.
- Prepares and coordinates the process for requesting records in advance of or in lieu of inspection from the regulated industry.
- Manages and coordinates the process for requests and information sharing with our State partners regarding compliance matters.
- Perform other duties as assigned.

## Requirements:

### Conditions of Employment

- U.S. Citizenship requirement or proof of being a U.S. National must be met by closing date.
- The candidate selected for this position will serve under a career or career-conditional appointment within the competitive service.
- Employment is subject to the successful completion of a background investigation, verification of qualifications, completion of onboarding forms, submission of required documents, and any other job-related requirement before or after appointment.
- Applicants must meet all qualification requirements by the closing date of this announcement.
- Direct Deposit: You will be required to have all federal salary payments electronically deposited into a bank account with a financial institution of your choice.
- FDA participates in e-Verify: All new hires must complete the I-9 form; this information will be processed through e-Verify to determine your employment eligibility. If a discrepancy arises, you must take affirmative steps to resolve the matter.

- One-year probationary period may be required.
- Financial Disclosure may be required.
- Ethics Clearance may be required.
- Background Investigation Requirement: All employees must pass a security investigation. Failing to pass the background check may be grounds for removal or legal action. If hired, you may be subject to additional investigations at a later time.
- Certification of Accuracy: All information concerning eligibility and qualification is subject to investigation and verification. False representation may be grounds for non-consideration, non-selection, or appropriate legal action.

## Qualifications:

### **Basic Qualification Requirements:**

*In order to qualify for this Title 21 (Cures) position, the candidate(s) must meet the following **requirements:***

- A bachelor's or graduate/higher level degree in quality assurance or a related degree that included at least 30 semester hours in one or a combination of the following: consumer laws, biological sciences, food science, chemistry, pharmacy, physical sciences, food technology, nutrition, medical science, engineering, epidemiology, veterinary medical science, legal investigations, law enforcement, or related scientific fields that provided knowledge directly related to consumer safety officer work.

The 30 semester hours may include up to 8 semester hours in statistics, or course work that included the principles, theory, or practical application of computers or computer programming.

OR

- Combination of education and experience – courses consisting of at least 30 semester hours in the fields of study described above, plus appropriate experience or additional education.
