We have approved your request received July 25, 2024, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for Respiratory Syncytial Virus Vaccine, Adjuvanted (AREXVY) manufactured at your facility in (b) (4), Belgium to update the Package Insert to include data from two clinical studies of concomitant administration of AREXVY with influenza vaccines in individuals 65 years of age and older.

The review of this supplement was associated with the following National Clinical Trial (NCT) numbers: NCT05559476 and NCT05568797.

LABELING

The SPL will be accessible via publicly available labeling repositories.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125775, at the time of use and include implementation information on Form FDA 356h.

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

For each pending supplemental application for this BLA that includes proposed revised labeling, please submit an amendment to update the proposed revised labeling with the changes approved today.

We will include information contained in the above-referenced supplement in your BLA file.
