Dear Dr. Lee:

We have approved your request received March 21, 2025, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for brexucabtagene autoleucel to remove references to Risk Evaluation and Mitigation Strategies (REMS) from the United States Prescribing Information (USPI) and to revise Sections 2 (Dosage and Administration), 5 (Warnings and Precautions), 17 (Patient Counseling Information) of the US Prescribing Information and Medication Guide, to align with REMS elimination and streamline monitoring for patients. This supplement is in response to our March 7, 2025, REMS Modification Notification letter.

LABELING

We hereby approve the draft content of labeling for the Package Insert submitted under amendment 1, dated June 9, 2025

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, please submit the final content of labeling (21 CFR 601.14) in Structured Product Labeling (SPL) format via the FDA automated drug registration and listing system, (eLIST) as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>. Content of labeling must be identical to the Package Insert submitted on June 9, 2025. The SPL will be accessible via publicly available labeling repositories.

We request that the labeling approved today be available on your website within 10 days of receipt of this letter.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125703/0 at the time of use and include implementation information on Form FDA 356h.

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

For each pending supplemental application for this BLA that includes proposed revised labeling, please submit an amendment to update the proposed revised labeling with the changes approved today.

We will include information contained in the above-referenced supplement in your BLA file.
