1. OVERVIEW

The Marketing Orders¹ require submission of an Annual Report with a summary of how the marketing of the tobacco products continues to be appropriate for the protection of public health, including “[a]ll final full color-advertising, marketing, and/or promotional materials, published, disseminated to adult smokers 21 years of age or older, or for use in engaging or communicating with consumers not previously submitted, along with the original date such materials were first disseminated and the date they were discontinued, and a description of all changes to the materials.”

Altria Client Services LLC (“ALCS”), on behalf of PM USA, submitted advertising, marketing, and promotional materials to the FDA through the 30-Day Notification process throughout the reporting period. The items we submit with this Appendix consist of marketing assets not previously submitted through the 30-Day Notification Process, including additional asset sizes not previously identified and previously submitted assets with changes to informational content (e.g., dates, text, and device images updates). These assets are the types of items addressed in FDA’s February 18, 2020 response to our specific requests regarding the manner in which to submit certain types of labeling and marketing materials to FDA².

With this context, [Table 1](#) below lists all materials not previously submitted as part of a 30-Day Notification. Each asset shows a date of dissemination and a date of discontinuation.

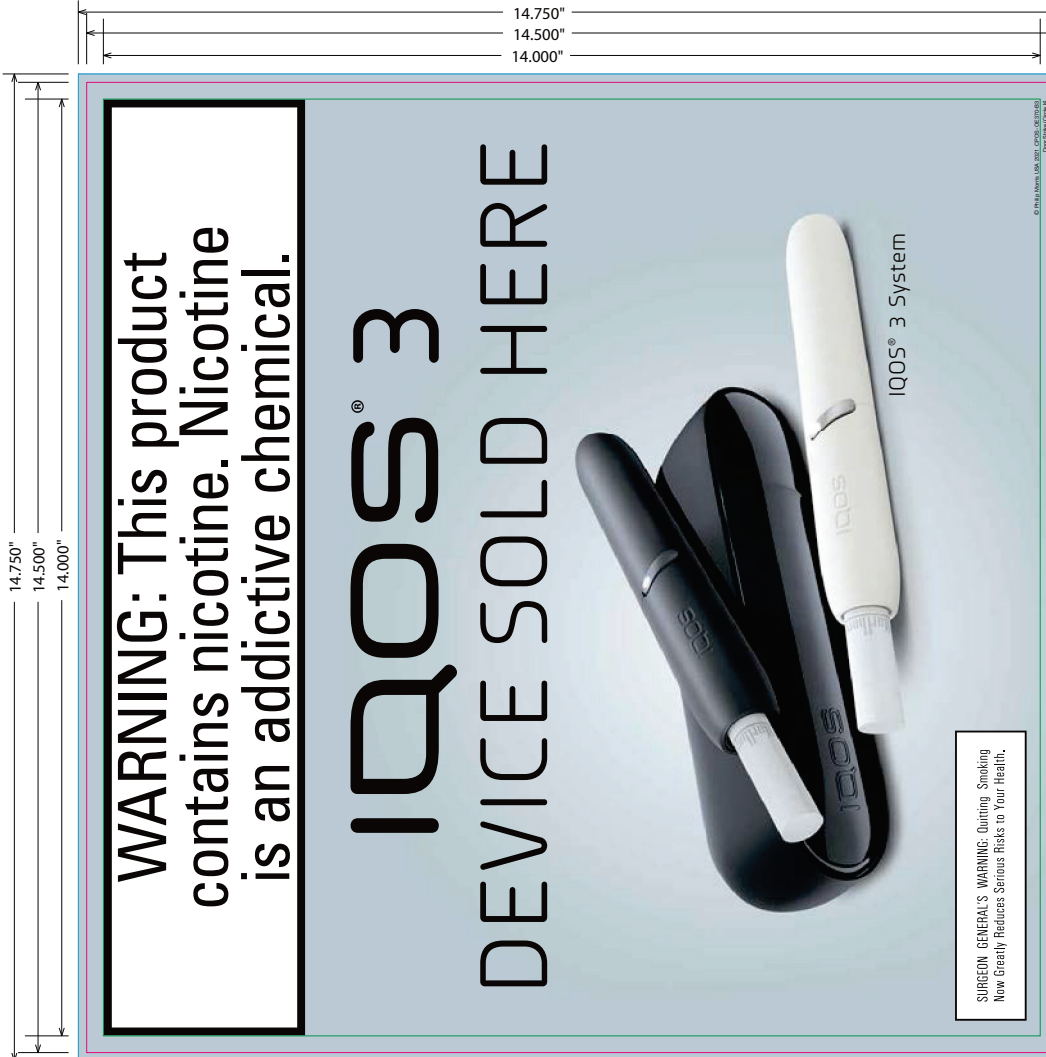

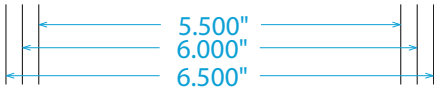
