

Submission Upload Workflow for Google Chrome version 142 (v142 or newer) and Microsoft Edge version 143 (v143 or newer) users

ESG NextGen Unified Submission Portal (USP) users utilizing Google Chrome v142 (or newer) or Microsoft Edge v143 (or newer) browsers will experience a modified workflow when uploading submissions. A new browser tab will open when FileCatalyst TransferAgent is launched. This document outlines the step-by-step process for this modified submission workflow.

Modified FileCatalyst TransferAgent Workflow

1. Log into the Unified Submission Portal (USP) and click on either the +NEW PRODUCTION SUBMISSION or Test Submission.
 - a. Agents/CROs/Consultants will need to select the company they are uploading on behalf of.
2. The Create Submission page will load and if your browser is Chrome v142 (or newer) or Edge v143 (or newer), instead of FileCatalyst TransferAgent loading within the USP, a message will show instructing to click 'LAUNCH NOW' to launch FileCatalyst TransferAgent.




How to Determine the Version of Your Web Browser

1. Open up your web browser (Google Chrome or Microsoft Edge)
