We have approved your request received October 28, 2025, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for etranacogene dezaparvovec-drlb to update the US Prescribing Information to reflect the updated efficacy and safety profile of HEMGENIX following the completion of the CSL222_3001 study.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125772 at the time of use and include implementation information on Form FDA 356h.
