We have approved your request received December 15, 2025, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for onasemnogene abeparvovec-brve to revise Section 8 USE IN SPECIFIC POPULATIONS, Section 12 CLINICAL PHARMACOLOGY, Section 13 NONCLINICAL TOXICOLOGY, and Section 17 PATIENT COUNSELING INFORMATION of the ITVISMA Prescribing Information to incorporate results from final reproductive and developmental toxicity study reports.

LABELING

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125856/0 at the time of use and include implementation information on Form FDA 356h.

We will include information contained in the above-referenced supplement in your BLA file.
