

**Salinomycin/Chlortetracycline-AUREO Broiler Feed Type C
Medicated Complete Feed**
(salinomycin sodium and chlortetracycline Type C medicated feed)

Caution: Federal law restricts medicated feed containing this veterinary feed directive (VFD) drug to use by or on the order of a licensed veterinarian.

For the prevention of coccidiosis caused by *Eimeria acervulina*, *E. tenella*, *E. brunetti*, *E. maxima*, *E. necatrix* and *E. mivati* and as an aid in the reduction of mortality due to *E. coli* infections susceptible to chlortetracycline.
