
DURING AN INSPECTION OF YOUR FIRM (I) (WE) OBSERVED

OBSERVATION 1

Not all galleys and places where food is prepared, served, or stored are clean and free from flies, rodents, and other vermin.

Specifically,

1. The forward galley (G1) of the Boeing 767-400 aircraft had approximately 8-11 apparent rodent excreta pellets found above the right door panel in the forward galley above ~~were~~ ^{where} food is prepared by the in flight stewards.
2. The forward galley of the Boeing 767-400 aircraft had approximately 10-20 apparent rodent excreta pellets found above the left door panel in the forward galley above ~~were~~ ^{where} food is prepared by the in flight stewards.
3. There was approximately 9-15 apparent rodent excreta pellets found on the right aisle of the aircraft over seats C3-C7.
4. The middle cross over galley (G2) had three areas in the ceiling panels where there were apparent rodent excreta pellets to numerous to count. The areas where they were found are directly over an area in the aircraft where food and drinks are stored. The area also had approximately 6 areas on the ceiling panels where there was apparent rodent urine found.
