#### 1. Center for Food Safety and Applied Nutrition (DCE).


- A. Provides leadership and direction for all Center activities and coordinates programs with other Food and Drug Administration (FDA), Department and government agencies, including compliance with the FDA Food Safety Modernization Act.
- B. Develops FDA policy with regard to the safety, effectiveness, and proper labeling of all regulated foods and cosmetic related products for human and animal use.
- C. Establishes and manages a program to maintain the highest level of quality and integrity for all Center laboratory studies and the processing of regulatory samples, and ensures that all laboratories are in compliance with Good Laboratory Practice Regulations.
- D. Coordinates with the Veterinary Medicine program regarding activities for veterinary related-drug products. Such activities include research, compliance, and product review and approval.
- E. Develops and disseminates information and educational material dealing with regulated foods and cosmetic related products to the community and the public in coordination with the Office of the Commissioner.
- F. Monitors marketed food products advertising and promotional labeling to assure their accuracy and integrity of regulated foods and cosmetic related products for human and animal use.
- G. In carrying out these functions, cooperates with other FDA components, governmental and international agencies, volunteer health organizations, universities, individual scientists, nongovernmental laboratories, and manufacturers of marketed and regulated foods and cosmetic related products to ensure food protection and cosmetic related products compliance.

H. Provides leadership and direction for FDA outbreak activities including preparedness, response, environmental assessments and post-response activities associated with FDA-regulated human and animal food, dietary supplements, and cosmetics.

### 2. Authority and Effective Date.

The functional statements for the Center for Food Safety and Applied Nutrition were approved by the Secretary of Health and Human Services and effective on December 14, 2018.
