1. Division of Acquisition Operations (DCNEBA).

- A. Provides mission specific contracts and simplified acquisitions, including research and development requirements, studies, and laboratory supply and equipment requirements.
- B. Provides contracts and simplified acquisitions services, to include but not limited to, document control room support, professional services, security, events management, temporary services, moving, library support, custodial, etc.
- C. Provides contract and acquisition services for research and development, scientific studies, scientific equipment and maintenance of scientific equipment.
- D. Plans, executes, and administers contract and orders in support of the mission.

2. Service Contracts Branch (DCNEBA1).

- A. Plans, executes, and administers contract and orders in support of customers' missions in accordance with regulation and policy. Commodities procured include: Temporary/Professional Services, Administrative Support, Training, Moving, Guard Services, Mail, Document Management, Conference/Event Planning, and (limited) Laboratory Equipment.
- B. Provides strategic advice to customers on cost effective and flexible strategies for satisfying their ongoing business needs.
- C. Provides contract and acquisition services for research and development, scientific studies, scientific equipment and maintenance of scientific equipment.

3. Contracts Operations Branch (DCNEBA2).

- A. Plans, executes, and administers contract and orders in support of customers' missions in accordance with regulation and policy. Commodities procured include: Building Security, Shredding, Office supplies, Parking, Shuttle Services, Advertising, Subscriptions, Data, and (limited) Laboratory Equipment.
- B. Provides strategic advice to customers on cost effective and flexible strategies for satisfying their ongoing business needs.


4. Scientific Support Branch (DCNEBA3).

- A. Provides cradle-to-grave contract support to all Centers within the FDA for acquisition and subsequent administration of contracts for: research and development (R&D), scientific studies, scientific equipment and maintenance of that equipment. Manages the FDA's Broad Agency Announcement (BAA) Program with the Office of Acquisitions and Grants Services.
- B. Provides strategic advice to customers on cost effective and flexible strategies for satisfying their ongoing business needs.
