# Division of Information Technology Acquisitions

Effective: October 9, 2020

#### 1. Division of Information Technology Acquisitions (DCNEBD).

- A. Responsible for planning, awarding and administering contracts and simplified acquisitions in accordance with regulation and policy for Information Technology requirements for hardware, software and services.
- B. Provides strategic business advice to customers on cost effective and flexible strategies for meeting ongoing and future information technology (IT) requirements.

# 2. Information Technology Acquisitions Branch (DCNEBD1).

A. Performs services for the acquisition and administration of contracts and simplified acquisitions which include, but are not limited to, the following commodities: IT-related hardware, software, and services from the information technology offices and primarily for the Center for Biologics Evaluation and Research (CBER), Center for Tobacco Products (CTP), Center for Veterinary Medicine (CVM), and Office of Regulatory Affairs (ORA).

# 3. Systems Technology Acquisitions Branch (DCNEBD2).

A. Performs services for the acquisition and administration of contracts and simplified acquisitions which include but not limited to the following commodities: IT-related hardware, software, services from information technology offices and primarily for the Center for Drug Evaluation and Research (CDER), Center for Devices and Radiological Health (CDRH), Center for Food Safety and Applied Nutrition (CFSAN), and Office of the Commissioner (OC) and the Offices that report to OC.

# 4. IT Strategic Support Branch (DCNEBD3).


A. Information Technology Strategic Support Branch (ITSS): Information Technology Acquisitions Branch (ITAB): Responsible for the acquisition and administration of contracts and simplified acquisitions which include but not limited to the following commodities: IT-related hardware, software, services from Office of Information Management.
