1. Office of Communication, Information Disclosure, Training, and Education (DCCE).

- A. Develops and coordinates overarching communication, training, and education activities for internal and external stakeholders.
- B. Provides strategic communication, training, and education advice to Center for Devices and Radiological Health (CDRH) and Food and Drug Administration (FDA) leadership.
- C. Provides expertise on core communication, training, and education tools for application in support of Center and FDA programs.
- D. Develops and implements strategies for obtaining, analyzing, and incorporating the views and needs of health professionals, consumers, and industry into the Center policy and decision-making processes as well as in problem analysis, resolution strategy development, implementation, and evaluation processes.
- E. Ensures consistency with FDA branding, messaging, and strategic direction.
- F. Maintains broad understanding of the informational, training and educational needs of regulated entities and the public.
- G. Effectively collaborates and coordinates with internal and external partners and stakeholders.
- H. Oversees Center activities pertaining to information disclosure.

2. Program Management Operations Staff (DCCE1).

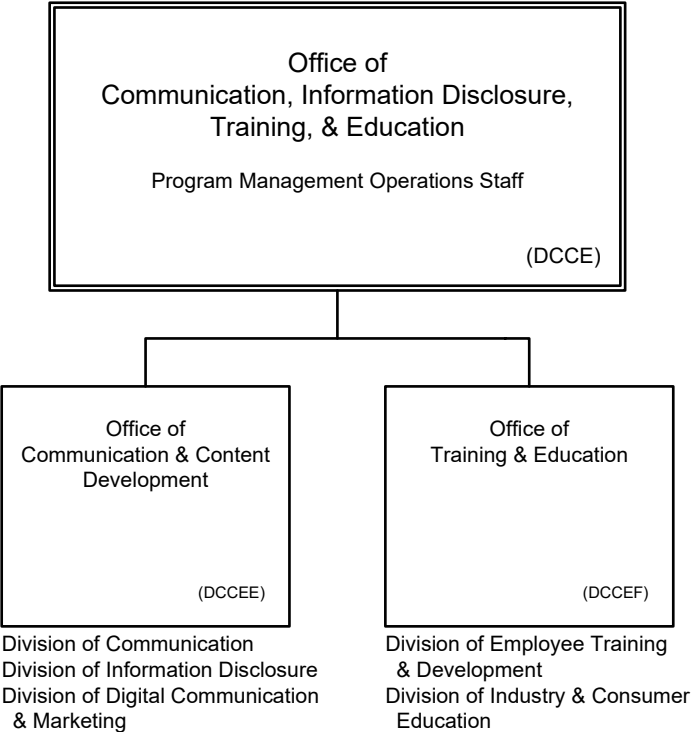
- A. Provides authoritative advice and guidance to the Office Director on administrative management matters, management policies, guidelines, issues and concerns that impact Office/Center programs and initiatives.

- B. Provides leadership, guidance and directs the development of long-range strategic management and operational plans, and systems for Office activities and directs technical support.
- C. Directs, coordinates, and controls the resource management activities of the Office.
- D. Coordinates and provides analysis, evaluation, and execution of business operations.

3. Authority and Effective Date.
