DIRECTIONS FOR USE

Feed 100-200 grams of lincomycin per ton of complete feed as the sole ration for 21 days.

CAUTION

Occasionally, swine fed lincomycin may within the first two days after the onset of treatment develop diarrhea and/or swelling of the anus. On rare occasions, some pigs may show reddening of the skin and irritable behavior. These conditions have been self-correcting within five to eight days without discontinuing the lincomycin treatment. The effects of lincomycin on swine reproductive performance, pregnancy, and lactation have not been determined.

Do not allow rabbits, hamsters, guinea pigs, horses, or ruminants access to feeds containing lincomycin. Ingestion by these species may result in severe gastrointestinal effects.



WARNING: No drug withdrawal period is required before slaughter of swine fed lincomycin at 100-200 grams lincomycin per ton of feed.
