## 1. Division of Program Services (DCBBB).

- A. Directs Center responsibility related to physical security and safety management services.
- B. Provides liaison support to shared services for property and facilities management.
- C. Oversees the general safety of all CBER personnel and ensures compliance with OSHA and CDC/USDA regulations.
- D. Develops training for research staff as pertaining to lab operations and general safety for all CBER occupants.
- E. Coordinates and distributes information on policy and procedures related to the management of safety programs.
- F. Supports the Center as Deputy Ethics Counselor Point-of-Contact (DECPOC) by coordinating and managing the Center's ethics program.

#### 2. Safety and Services Branch (DCBB4).

- A. Oversees the general safety all CBER personnel and ensuring compliance with OSHA and CDC/USDA regulations.
- B. Administering the Center's Respiratory Protection Program (RPP), Chemical Surveillance Program, Biosafety Programs and Animal Safety Program.

- C. Facilitating collaboration with FDA facilities, FDA Occupational Health Services, Federal Protective Services, and Montgomery County Fire Department as they overlap with CBER safety programs.
- D. Developing training for research staff as pertaining to lab operations and general safety for all CBER occupants.
- E. Coordinating and distributing information on policy and procedures related to the management of safety programs.
- F. Providing consultation to researchers regarding the use of chemical and biological material, and strategies to reduce physical injuries related to their use and the use of animals.
- G. Overseeing the development of safety programs for White Oak operations.
- H. Auditing all CBER laboratories for potential safety risks and subsequently providing recommendations.
- I. Investigating accidents and injuries of CBER staff to determine the root cause and refine training initiatives.
- J. Promoting safety awareness throughout CBER including labs, offices and the animal facility.
- K. Managing contracts that relate to safety in support of scientific programs.

# 3. Program Services Branch (DCBB1)


- A. Provide facility and space liaison services to employees, supervisors and managers.
- B. Coordinate and distribute information on policy and procedures related to the management of CBER's offices.
- C. Oversee facility projects for White Oak operations.
- D. Oversee CBER's managed print program and printer hubs.
- E. Coordinate the personal security for CBER employees including coordinating employee badging, liaison with FDA on employee background checks and assisting with lock and card reader issues.
- F. Manage accountable property for the center.
- G. Coordinate and manage IT programs and systems including PC refresh, IT coordinator program, eOrder system, choose your own device program.
- H. Administrator for hire to retire systems; eArrive, EASE, eDepart.

- I. Coordinate onboarding of non-FTEs.
- J. Manage logistic programs such as fleet management, metro cards, mobility scooters and campus ship.
