### 1. Office of Nutrition and Food Labeling (DCEK).

- A. Provides policy development and management of food and nutrition labeling, conventional foods, special nutritionals (including infant formula and medical foods), and associated educational initiatives.
- B. Develops regulations, compliance policy, position papers, regulatory guidelines, and advisory opinions for matters within the scope of the responsibility of the Office.
- C. Provides expert advice to the Center Director, other key officials, and directs major Food and Drug Administration (FDA) and Department nutrition and food labeling initiatives.
- D. Manages and provides scientific review on issues related to infant formula and medical foods including petitions and notifications and provides advice to key FDA components as well as international bodies.
- E. Provides clinical and scientific expertise on the design and conduct of clinical trials, risk assessment, adverse event reports, and educational initiatives related to infant formula and medical foods.

# 2. Infant Formula and Medical Foods Staff (DCEK3).

- A. Provides technical knowledge and expertise in composition, nutrition, and safety of infant formulas set forth under the Infant Formula Act of 1980, and subsequent amendments.
- B. Manages and provides scientific review and analysis of infant formula submissions, petition dossiers, and inspection records as they are submitted

in order to determine if the quality factor requirements for infant formula (21 CFR 106.96 and 21 CFR 106.121) have been met.


- C. Develops regulations, compliance policy, position papers, regulatory guidelines, guidances, and advisory opinions for matters within the scope of infant formula and medical foods.
- D. Provides expert advice to the Office Director, Center Director, other key officials and national and international bodies on infant formula and medical foods initiatives and issues.
- E. Provides clinical and scientific expertise on the design and conduct of clinical trials for stakeholders, risk assessment, and adverse event reports. Provides training for, and feedback to FDA Field investigators in order to strengthen FDA's oversight on issues related to infant formula and medical foods.

### 3. Authority and Effective Date.

The functional statements for the Office of Nutrition and Food Labeling were approved by the Commissioner of Food and Drugs, FDA effective on October 9, 2020.
