
1. Office of Program & Regulatory Operations (DCDLG).

- A. Leads and manages the business processes, quality management system, and training and development system within the Office of Pharmaceutical Quality (OPQ).
- B. Leads and manages all processes associated with drug quality reviews and facility inspections, in collaboration with OPQ functional office leadership.
- C. Designs, develops, and implements internal processes to support the drug quality reviews and inspections.
- D. Monitors, reports and leads corrective and preventive actions relating to the performance of internal processes, as defined by standard procedures.
- E. Designs, develops, and implements OPQ-specific training and developmental programs to ensure the skill sets and competencies of staff are maintained and continually improved.
