Detroit District's Import community includes The Ambassador Bridge, North America's #1 International Northern border crossing. It spans the Detroit River connecting Detroit, Michigan with Windsor, Ontario, Canada. The Blue Water Bridge connects Port Huron, MI. with Sarnia, Ontario, Canada. It is now the 4th busiest Northern border crossing for trucks. Approximately 10,000 trucks cross the bridge daily. The International Bridge connects Sault Ste. Marie, MI., to Sault Ste. Marie, Ontario, Canada. In addition to the border crossings, we monitor airports, and a Federal Express Air Courier Hub in Indianapolis, IN. FDA-regulated commodities entering through these ports include food, drugs, medical devices and radiological products, biologics, and cosmetics.

The Detroit District Office currently staffs offices with Domestic staff in Indianapolis, IN., Evansville, IN., Fort Wayne IN., South Bend, IN., Grand Rapids, MI., and Kalamazoo, MI. We also maintain offices at both the Ambassador Bridge in Detroit, the Blue Water Bridge in Port Huron and the International Bridge in Sault Saint Marie.
