DURING AN INSPECTION OF YOUR FIRM WE OBSERVED:

OBSERVATION 1

Your written SE prevention plan lacks appropriate SE prevention measures.

Specifically, during review of your written "SE MONITORING AND CONTROL PROGRAM", on 4/12/2011 it was noted that your plan lacks:

- SE monitoring of pullets and procurement of chicks
 - Cleaning and disinfection procedures
 - Practices that will protect against cross contamination when persons and equipment move between poultry houses
- Prevention of stray poultry, wild birds, cats, and other animals from entering poultry houses

OBSERVATION 2

Stray animals are not prevented from entering poultry houses.


Specifically,

- On 4/12/11, during our walk through of house 40 there were 4 visible birds nest underneath the roof of the house.
- On 4/12/11, during the walk through of house 33 there were 4 large wild birds laying between houses 32 and 33. The birds were observed walking through house 33.
- On 4/12/11, one of your employees collecting eggs from house 20 and 21 was using a push cart, on the bottom of the push cart was a dog, who rode along as the employee collected eggs.

OBSERVATION 3

You do not maintain practices that will protect against cross contamination when equipment is moved among poultry houses.

Specifically, your ranch has no procedures in place to protect against cross contamination when equipment is moved among poultry houses.

OBSERVATION 4

You do not maintain practices that will protect against cross contamination when people move between poultry houses.
Specifically, your ranch has no procedures in place to protect against cross contamination when people move between poultry houses.

OBSERVATION 5

Environmental testing for SE, using approved methods, was not done in a poultry house when any group of laying hens constituting the flock was 40 to 45 weeks of age.
Specifically, you took environmental swabs of Group ~~88~~ when the age of the birds was 47-48 weeks.

OBSERVATION 6

You did not maintain records documenting compliance with cleaning and disinfection procedures performed at depopulation.
Specifically, when asked about your cleaning and disinfection records, your ranch manager stated that no documents were kept for cleaning and disinfection procedures performed at depopulation for your ranch.

OBSERVATION 7

Your written SE plan does not bear a date and carry the signature(s) and not the initials of the person(s) who administer the plan.
Specifically, during review of your written "SE MONITORING AND CONTROL PROGRAM" on 4/12/2011, it was noted that your plan lacks the date and the signature of the person who is administering the plan.
